3. The appeal may be filed either: (i) **Online**, through the ECI NET platform at: <https://ecinet.eci.gov.in> or (ii) **Physically**, at the office of the DM/SDM/SDO, who shall ensure digitization and uploading of the appeal on the ECI NET platform at the earliest.
4. This notification shall come into force with immediate effect and the above tribunal shall cease to exist immediately after all appeals are disposed of in the respective districts.
